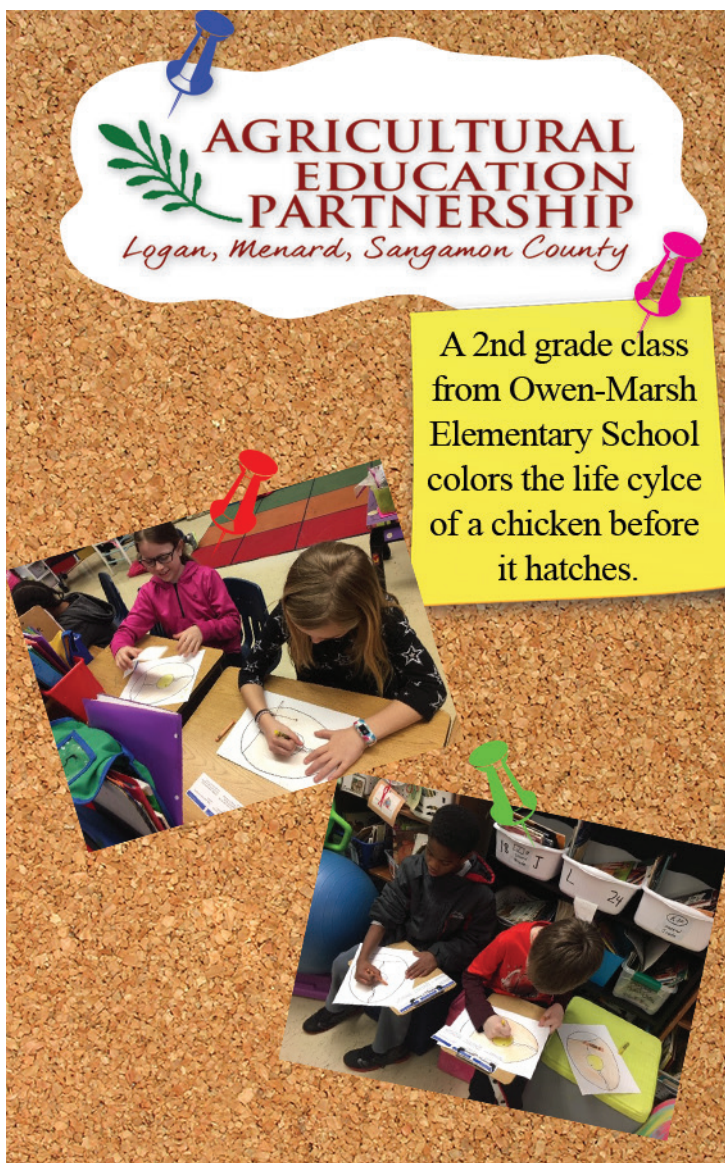

It's hard to sit and wait to get in the field because of cool, wet weather. With so much to do this spring, folks are getting itchy. So, I try to look on the bright side, and that is the time we've been allowed to keep our attention on the happenings at both the state capitol and in DC. There's been no shortage of issues and legislation to keep everyone busy.

One of the biggest issues on the plate is the contemplation of a graduated income tax for Illinois. Illinois Farm Bureau's policy states, "We prefer a flat rate state income tax, and support deductions and credits benefiting agriculture and agricultural processes, and an exemption at some realistic level. We support the State of Illinois following Federal Depreciation rules regarding bonus depreciation." While we must find a solution to our drowning debt, this is not the solution Illinois Farm Bureau feels is in

the best interests of our members bottom line. An action request to contact your senator will be or by this time has been issued. Please make your voice heard on the matter.

Still on state issues, the Illinois Department of Agriculture has requested a waiver from USEPA to allow them to augment the regulations for applying dicamba products in Illinois. The rules would be more stringent and include implementation of a cutoff date of June 30th as being the last day dicamba can be used during the growing season. While there's been some support for this among ag groups, that support has been eroding in the countryside. If regulations are put in place to create a cutoff date of June 30th for use of dicamba this could cause late planted crops, as might be the case this year, to not have the opportunity to benefit from dicamba products when they're needed. A June 30th date could also have the negative effect of applicators trying to get the product applied on the last date even if conditions aren't optimal. This could create some of the very situations the additional regulations are meant to address.

There are many more state legislative issues on the table this year. Some benefit agriculture while many others are detrimental to it. County and state leaders and staff are working every day to affect the outcome of hundreds of bills. You can see a brief summary of bills and Farm Bureau's position on page 6 of this edition of the Sangamo Farmer.

On the federal side of legislation, there's the ongoing issue of trade and getting agreements in place with China, Mexico, Canada and others to allow fair and equitable trade of your agricultural products. This is obviously an internationally spotlighted issue and has many moving parts. Farm Bureau is in partnership with many other organizations whose members they represent are affected by these trade barriers. Standing as one, we're making some slow but steady progress.

I hope everyone gets the opportunity to prep their fields and get them planted in a timely and safe manner. In the meantime, we'll continue to look out for your best interests at all levels of government.

Our Policy Development Committee is always trying to encourage members just like you to provide ideas to us that you feel Farm Bureau needs to address. It's often misunderstood that we are looking for members to provide us with the issue, have a solution in mind, and have official policy language put together. This is far from the truth. All we really need

to get started is one thing....your idea.

The ideas we seek are often simple commonsense thoughts that no one has thought to address in policy. Although others can be complex matters that require significant consideration. Either way, that's why the Policy Development Committee exists, to drive Farm Bureau's efforts toward issues affecting you.

To give you an idea of what policy looks like, one of our most recent issues brought to our committee from a member related to LLCs and farm program payment limitations. The member's farm is an LLC and is only allowed one payment limitation although there is more than one individual who owns it. Farms created as a general partnership have individual payment limitations for each owner. This is an unfair rule that affects farmers who are trying to limit their liability

exposure. You can find this and all Illinois Farm Bureau policies at <http://www.ilfb.org/take-action/current-priorities/developing-ifb-policy/2019-policy-book/>. Or call our office and we can email you a copy.

Our committee REALLY wants your ideas on issues affecting you. Maybe they're already in policy and just need to be pushed harder or maybe it's something new that needs looking into. Either way, as a grassroots organization, you have the power to help steer the Farm Bureau ship! Make sure you use it.

Finally, after approximately a year of vacancy we're blessed to have filled the position of Outreach & Communications Specialist in our office. The staff are thrilled to put someone on the team to help get everything done!! The new member of our team is Lauren Burris. Lauren is a local girl from the Middletown area. She is a recent graduate of Oklahoma State University and has considerable livestock experience. Lauren has been on the job since March 11th and has been working hard to put together this issue of the Sangamo Farmer for your reading pleasure. WELCOME LAUREN!!!

Until the next issue, please be safe as you work to get fertilizer on, crops planted, and sprayed. Never forget that the most valuable assets of your farm are you and your family. Make sure you protect those assets well!

STATE BILL STATUS

COUNTY CONTROL OF THE LMFA – SB 1481 (Sen. Koehler)

This bill states that, for proposed livestock farms over 1,000 animal units, a county board shall submit a binding recommendation to the Illinois Department of Agriculture (IDOA) about the proposed new farm's construction. After reviewing the binding recommendation, the IDOA is required to deny any permit to construct if the county recommends that the farm not be constructed. If the county recommends the construction of the farm, then the farm must also receive approval from the IDOA. SB 1481 has not passed out of committee. IFB opposes SB 1481.

LAWSUITS AGAINST ADMINISTRATIVE DECISIONS - HB 2839 (Rep. Gong-Gershowitz)

HB 2839 would allow any person to file a lawsuit against an agency and the person involved in a permitting decision or approval, including the approval of a livestock farm under the LMFA. This undermines existing case law that a person must be a party of record to the administrative decision to challenge that decision in court. This will result in farmers and others seeking approvals from state agencies facing costly lawsuits from any person that does not agree with the approval. It will grind development of the agriculture economy to a halt. HB 2839 is in the Rules Committee. IFB opposes HB 2839.

UNIFORM PARTITION OF HEIRS PROPERTY ACT – SB 1780 (Sen. Crowe), HB 3677 (Rep. Didech)

SB 1780 and HB 3677 are identical bills that would allow for a right of first refusal of heirs of property upon a forced sale. The Uniform Partition of Heirs Property Act preserves the right of a co-tenant to sell his or her interest in inherited real estate, while ensuring that the other co-tenants will have the necessary due process to prevent a forced sale, the bill establishes a right of first refusal to co-tenants. HB 3677 and SB 1780 have both passed their respective chamber and are awaiting votes in the opposite chambers. IFB supports SB 1780 and HB 3677.

VEGETATIVE BUFFER REQUIREMENT FOR STATE LAND – SB 1231 (Sen. Morrison), HB 2930 (Rep. Mason)

This bill would require that vegetative buffer strips be installed on all state property adjacent to a body of water. The buffer must be a minimum of 30-feet in width. Land covered by roads, buildings, or other structures; public or private water access for recreational use; certain properties regulated by an NPDES permit; or property in a temporary non-vegetative cover due to plant seeding or other construction activities is exempted from the requirement. SB 1231 was postponed and referred back to Assignments. HB 2930 has been held in the Rules Committee. IFB opposes SB 1231 and HB 2930.

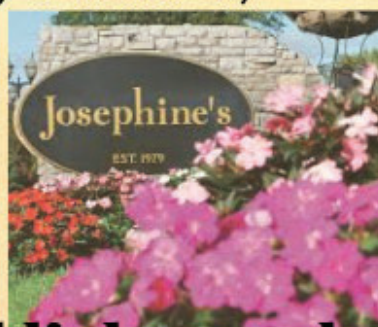
