

PURPLE PLUM TORTE

TORTE:

1 pkg. Lemon Cake Mix

4 eggs

½ pt. sour cream

1 1/2 cup diced fresh purple plums

7 fresh purple plum halves

Confectioners' sugar

CREAM CHEESE TOPPING:

1 pkg. Cream cheese

½ cup sour cream

2 tbsp. confectioners' sugar

2 tsp orange zest

Mix cake mix with eggs and sour cream. Beat three minutes at medium speed. Fold in diced plums. Arrange halved plums skin side down in greased bundt pan. Top with cake batter. Bake at 350 for 40 – 45 minutes. Let stand for 5 minutes; turn over on wire rack and sprinkle with confectioner's sugar when cool. Serve with cream cheese topping. Blend cream cheese (room temperature), sour cream, confectioners' sugar, and orange zest. Chill to blend flavor.



pleased and I look forward to next years event with more golfers and more hole sponsors, seems each year we grow a little more and I am excited about that!



Farmer Hall OF FAME



GHUGK FRAZEE Would like to introduce this year's Farmer Hall of Fame inductee, Chuck Frazee. Chuck was inducted at the 2016 county Annual Meeting in July.

Charles Joseph Frazee was born on November 8, 1940 to Elmer and Helen Frazee, Divernon. After graduating from Pawnee High School he attended Western Illinois University for his undergraduate degree and then the University of Illinois for his Master's and Ph. D. in Agronomy. He married Lois Summers in 1965 and they have two children Laura (Joe) Pickrell and Joe (Sarah) Frazee and 4 grandchildren.

Chuck was a professor of Agronomy at South Dakota State University from 1969-1975. As a professor he taught soils and conducted research in remote sensing. In 1975, he returned to the family farm, Round Barn Farms Inc., to farm with his father and brother Tom. The farm became a sesquicentennial farm in 2012. Upon returning to the farm, Chuck expanded the hog operation to a 200 sow farrow to finish operation. They also raised corn and soybeans and were one of the early no-till farmers in the area.

Chuck was very active in Sangamon County Pork Producers and is well known for grilling some of the best pork chops in the area. He was a 4-H leader for 20 years. He has served on the Soil and Water District Board for over 35 years. He also served on the Farm Bureau Board for 9 years and has been on numerous committees within the Farm Bureau. He was appointed and served on the Illinois Fertilizer Research and Education Committee for 4 years. He was elected to serve on the Sangamon County FSA committee for 12 years. Chuck is a charter member of the Sugar Creek United Methodist Church in Chatham. He has served as trustee and a treasurer of the United Methodist Men's group.

He currently operates a soil consulting business that provides soil analysis for septic systems. He has operated Frazee Soil Consulting for 20 years and has served many area Farm Bureau members.

Chuck's comment: "Farming has seen many changes but soil conservation is still important for future generations to feed the world."

As usual, Sangamon County Farm Bureau experienced a very busy summer with lots of activities and events. By the very nature of those we serve, we have a rather narrow window between planting and harvest to cram a lot of things in. Yet we obviously have to

compete with all the other things people do during these same months such as attend county fairs, bale hay, scout fields, take family vacations, and so on.


For that and many other reasons I'm so proud of our nearly 90 volunteers that put hard work into all these activities throughout the year. I'm equally as proud of our dedicated staff that puts their hearts and minds into these events. It takes both sets of people to get things done and it's demonstrated time and again that they make our organization one of the best Farm Bureau's in the state.

Shifting gears to a note of special importance to our area. The Lake Springfield Watershed and indeed every acre of farmland in the state need to have nutrient loss practices put into place if we're to avoid the potential of being the next Des Moines, Iowa style lawsuit. I know it sounds difficult and like it's just one more thing to have to manage. First off, it's not nearly as difficult as many believe and the risks for doing nothing are very real. This risk was nearly realized earlier this year when nitrate levels in Lake

Springfield spiked to within a fraction of making the lake unusable for drinking water. That would've required CWLP to provide bulk and bottled water to all residents they serve. If you don't think you and/or your tenants would've been the ones singled out by 150,000 local people, think again. That sort of catastrophic event would haunt every single farmer in this area and others. Let's make sure we take responsibility for ensuring this never happens. We'll either be the heroes or the villains. It's our choice which. So as harvest begins and fall fieldwork ensues be sure to consider cover crop plantings and other simple practices.

One last thing before I let you go. As the busyness of harvest gets underway, please remember one thing. YOUR SAFETY AND THAT OF YOUR FAMILY AND EMPLOYEES SHOULD BE THE NUMBER ONE PRIORITY EVERY MINUTE. I know as well as any of you that we get focused on the tasks of getting the crop out, but you must constantly remind yourself of safety. One of the least thought of safety issues is fatigue. Just a few more rounds; gotta get the trucks loaded first before quitting for the night; ought to move to the next field while traffic is light, and so on. Pushing yourself and others when you're tired (even if you don't realize you are) can be very dangerous and someone can quickly get injured or killed in the process. Looking back, no one would ever say, "Well, at least it was worth it." So stay safe and alert. Others in the field or on the road may not, so it's up to you.

Have a safe and blessed harvest.





Committee Reports

At our last meeting we discussed a series of three ballot initiatives proposed by the Citizen's Efficiency Commission. The Farm Bureau Board of Directors had previously lent its support to the County Board to put the initiatives on the ballot. The Farm Bureau didn't vote to support or oppose any of them but wanted the people to

have the opportunity to tell the county and townships what they want or don't want. In the end only one of the initiatives discussed was approved by the County Board to be placed on the ballot.

We also received a legislative update from Bill Bodine, Assistant Director of State Legislation for Illinois Farm Bureau. Bill brought the committee up to speed on the federal issues of TPP, Cuba, GMO Labeling, and atrazine reregistration. He also reported on the state budget, filter strip property tax reductions, the telecommunications bill, and the Independent Map Amendment.

The committee reviewed the voting records of state legislators and the award recipients for the Friend of Agriculture Award. In our area, Senators Brady and McCann received the award along with Representatives Butler and Wojcicki-Jimenez. Thanks and congratulations goes out to these legislators.

Just before we get in the fields for harvest we'll be taking five leaders to the Illinois Agriculture Legislative Roundable meeting at a farm in Bloomington. We'll be hearing from U.S. Senate candidates Senator Mark Kirk and Congresswoman Tammy Duckworth.

My best to all of you as you work the long hours to get through harvest. Be safe.

ur committee has been approached with a couple suggested policy matters to be considered for formal Illinois Farm Bureau policy debate at their annual meeting in December. One policy submittal would deal with changing the date that landowners must notify tenants of non-renewal of

farm lease. In working with our lobbyists it appears that the date change might not be appropriate for other parts of the state and other types of crops grown. The policy was not submitted for discussion.

The other policy suggestion was to encourage our affiliates to do more to offer E85 at their fuel stations. That policy will be discussed at the annual meeting in Chicago.

Hello everyone! We have been busy with a few events this month. It was good to get these in before folks started gearing up for the harvest season. We held our yearly Pre Harvest Market Outlook Steak Fry, Corn Yield Survey and a Truck Regulation Seminar.

Our guest speakers from Ag Yield spoke about the current market

conditions and their opinion about the upcoming season at our Steak Fry. Their outlook was not very optimistic for higher corn prices. With large reserves of old corn still on hand coupled with a potential bumper crop the prices are mainly going to be sideways for a while. They did report that the markets did not respond negatively to the latest USDA crop report that bumped up their yield outlook from their last report. Exports are stable, but what can make a big difference in corn prices is ethanol and RFS. There is a lot of focus on the upcoming presidential elections. What will the next administration do with ethanol and the RFS?

Now on a positive note, the steak dinner was wonderful! Thick cut ribeye steaks, baked potato and salad. A big thanks to Jim Birge and his staff for all their help setting this event up.
